I respect your privacy and I am committed to protecting it. The only personal information I directly collect from you, with your consent, is your name and email when you subscribe to my email updates and your name, email, phone number, address and information about food allergies when you register for a conference, event or retreat.

I use Get a Newsletter to create and deliver my email newsletters. If we have been in contact I may add your name to the Newsletter mailing list, from which you are free to unsubscribe at any time. I may send out an occasional email letting you know about upcoming yoga retreats, workshops or other services. My email service provider, like every other email service, will automatically store your name, email address and email whenever you contact me to be able to reply to your enquires.

I do not share, sell or trade your name and email address with third parties.

PUBLICLY VISIBLE INFORMATION

If you leave a comment, via for example Facebook, Instagram or your Google account certain information may be publicly visible. Your email address will never be available publicly.

COOKIES

Like any other website, eventsbycarol.se uses 'cookies'. We use cookies from Google to deliver its services and to analyze traffic. Your IP address and user agent are shared with Google, together with performance and security metrics, to ensure quality of services, generate usage statistics and to detect and address abuse. By using this site, you agree to its use of cookies.
